Holidays take priority. Neither party shall be entitled to any "make up" time in the event that a holiday falls on a regular parenting opportunity, unless the parents agree to a different arrangement in writing.

By signing the present agreement, the parents stipulate that the issues contained herein are settled and cannot be changed unless (1) consent is provided by both parents in writing to modify or (2) you satisfy a legal standard known as a *substantial change of circumstance*.
